Max Castle attended a Public Forum at the 28 April Council Meeting. He has provided the following report.

Hi all,

Presentation of petition (1500 signatures) initiated by fishing clubs was presented to Council counter staff at about 12.20pm on the 28th of April.

About 50 - 60 people attended the steps of Council to hear an address from Uncle Terry Hill and Clr. Anthony Mayne.

Mick Thompson was to speak but was an apology at the last minute as he was required at another meeting

Coopers Island topic was placed at the bottom of the presentation list for the Forum which resulted in a reduction of time to 2 minutes for speakers wanting to read their presentation. This action has resulted in a lot of community criticism.

Council voted to NOT sell Coopers Is Rd. which is a great outcome so far.

Peter Cormicks presentation highlighted the lack of information sent from Council to Crown Lands to enable them to make an informed decision and then advise Crown Solicitors.

My presentation was not read out due to a lack of time. (copy can be provided)

Anthony Mayne asked me a question regarding what involvement our first nation had particularly relating to consultation – I responded nil.

Council will re contact Crown Lands for further discussions.
